

NetWitness Hawaii Sweepstakes Official Rules

OFFICIAL RULES. NO PURCHASE NECESSARY.

Open only to prospects or clients of NetWitness(Sponsor) or those in our industry within the US (excluding FL and NY), who a) are 18 years of age or older as of April 24, 2023, or b) reaches the age of majority in the state/province/territory of residence if the age of majority is not 18 (19 IN AL AND NE; 21 IN MS), whichever is older, c) US citizen.
